Terms and conditions

§1 Service definition

Summonable address in Nuremberg; receipt of mail and small packages; small nameplate on the mailbox. The service requestor may use the address “Josephsplatz 8, 90403 Nuremberg, Germany” or “Henkestraße 91, 91052 Erlangen“ where the “Coworking Space Nürnberg or Erlangen” will receive mail and small packages and keep them in a post box. Also included in the “business address premium” subscription is the usage of the Coworking Nürnberg office space on one day per week. (Announcement via mail@coworking-nuernberg.de, not transferable to subsequent weeks or months)

§2 Mail forwarding

On request, we will forward your mail to a specified address one time per week against a fee of 25 € incl. VAT per month.

§3 Contract duration and cancellation

The subscription runs for an indefinite time and can be canceled by both parties up to 10 days to the end of the subscription period. The subscription period and the minimum contract duration is 3 months. The “Coworking Nürnberg GmbH” can cancel the subscription without notice if the service requestor is in arrears with his payments by more than 4 weeks, does not comply with these conditions or if it is found that the service requestor undergoes a dishonest business.

§4 Rent and Payment

The prepaid rent for the business address subscription is 69,00 € incl. VAT /month. It is invoiced every 3 months and paid via SEPA direct debit.

§5 Contractual amendments / severability clause

The assignment of rights from this contract to third parties by the service requestor is not allowed without the permission of the “Coworking Nürnberg GmbH”. Additions or exceptions to these conditions must be agreed in writing; There are no verbal side agreements. Insofar as these Terms should be invalid in whole or in part, this shall not affect the remaining terms of the contract. The place of contractual fulfillment and exclusive court of jurisdiction is Nuremberg, Germany.
